An Arab sample of 53 cases was subjected to the original validation procedures which involved a preliminary exercise and a translation from English to Arabic. Acceptable equivalent meanings of Beck's depth-of-depression criteria were established by the Arab clinicians so that independent and valid clinical ratings could be made.

The Arabic Version of Beck's Depression Inventory - II (BDI-II): It is a 21 item inventory which measures the severity of self-reported depression over the last two weeks; its item content corresponds to criteria for the diagnosis of depressive disorders as specified in the DSM-IV. It is the items that are structured on a 4-point scale ranging from 0 (Symptom not present) to 3 (Symptom strongly present).
