The provisions on possession proceedings in the Civil Procedure Rules under CPR 55.29 have yet to be amended to reflect this extension. As of the 24 August 2020, the position reverts back to the pre-Covid position; that is the notice periods are reduced (2 months for a s21 and 2 weeks for 8 weeks of arrears), proceedings can be issued at Court, and enforcement action may be commenced against those tenants in breach of a Possession Order.

The defence must be in the standard form, using form N11R (or form N11B in case of accelerated possession proceedings). Alternatively, if the claim has been started using the Possession Claim Online (PCOL) service, the defendant can file a defence, or a defence and counterclaim, using PCOL (see the page on Online claims for more information).

### **Form N11R: Defend a claim for possession of a rented ...**

If the tenancy has been brought to an end with a section 21 notice then the landlord needs to decide whether to pursue a judgment for any rent arrears or just to get a possession order: - If just possession then ACCELERATED POSSESSION PROCEEDINGS - If possession and judgment for rent arrears then STANDARD POSSESSION (SECTION 21) PROCEEDINGS.
