Generally speaking, a tort is when one person or entity inflicts an injury upon another in which the injured party can sue for damages. In tort lawsuits, the injured party —referred to as the "plaintiff" in civil cases (comparable to the prosecutor in a criminal case)— seeks compensation, through the representation of a personal injury attorney, from the "defendant" for damages incurred (i.e. harm to property, health, or well-being).
